ADA Solutions, Inc. Files Lawsuit Accusing Armor-Tile and Access Tile Replaceable Cast in Place Tactile Warning Surface Products of Patent Infringement

Chelmsford, MA -- **ADA Solutions, Inc.**, the leading US manufacturer of Tactile Warning Surface Products, has initiated a patent infringement lawsuit in the United States District Court for the District of Massachusetts against **Engineered Plastics, Inc.** ("Armor-Tile") and **Access Products, Inc.** ("Access Tile"). In the lawsuit, ADA Solutions alleges that the Armor-Tile Replaceable Cast in Place and Access Tile Cast in Place Replaceable TWS Products offered for sale by Engineered Plastics, Inc. and Access Products, Inc. and its agents infringe recently issued U.S. Patent No. **7,779,581**, which is owned by ADA Solutions, Inc. The lawsuit also alleges that the installation of Armor-Tile and Access Tile Replaceable TWS Products violates ADA Solutions' patent rights.

ADA Solutions manufactures and sells ADAAG (Americans With Disabilities Act Accessibility Guidelines) Compliant Tactile Warning Surface Products used for Municipal (Curb Ramps), Commercial (Retail Establishments), Institutional (Educational Facilities, Hospitals), and Transit Facility Applications (Platform Edges) throughout North America. Truncated Dome Tactile Warning Surface Products, via visual, audio, and tactile cues, warn pedestrians, including those with a disability such as visual impairment, of potential impending danger such as an active roadway or a transit platform edge.

Among other advantages of the patented technology, ADA Solutions' Wet Set Replaceable TWS Products can be efficiently replaced when necessary. John Flaherty, President of ADA Solutions, explained, "ADA Solutions has invested in research and development to create new and improved TWS Products that offer benefits to customers seeking to comply with the American Disabilities Act Accessibility Guidelines. We have obtained patent rights in return for our investment, and we intend to enforce our patent rights against infringers." The lawsuit seeks monetary damages and an order requiring the accused infringers to cease selling the infringing TWS Products. ADA Solutions is represented in the lawsuit by Balliro & Mondano and Nelson Mullins Riley & Scarborough.
